A key focus has been the post-16 transitions of disadvantaged and disaffected young people faced with diminishing labour market opportunities and increasing employer demand for skills and qualifications.
	 While it is the impact of my research on post-16 education, training and employment policy formulation and knowledge about youth transitions, which has cemented my reputation in the policy and academic research communities in the UK, across Europe and internationally, I have undertaken a breadth of research covering the employment and skills landscape. From 2011 to 2013, I was a Visiting Research Fellow at the UK Commission for Employment and Skills (UKCES) and was commissioned, in 2013, to conduct further analysis of the UK Commission's Employer Skills Survey 2011, focusing on staff retention and skills deficiencies.
